Client Name

This agreement, between Sharing is Healing, Shawn Roling and the above named client will begin on the date the form is completed.

FEE

There is no fee for the initial meet and greet. Subsequent meeting appointments will be as follows: --\$40/hour for 1-1 mentoring/conversation/work in person or virtually --\$30/2 hours if attending an event together. Each individual will be responsible for their own entrance fee/food costs as applicable. --\$15 for phone call/text conversation check in.

- These fees will be paid on a monthly basis within two weeks of receiving your invoice.

- If you need to cancel an appointment, please provide at least 24 hour's notice when possible or you will be charged for the appointment.

SERVICES

The services to be provided by the mentor to the client are face-to-face, virtual or telephone/text mentoring, as agreed jointly with the client and payer . Mentoring may address a variety of skills, experiences and challenges. Individualized preferences will be selected from Sharing is Healing Mentor Options List. Throughout the working relationship, the mentor will engage in direct and personal conversations. The client understands that successful mentoring requires a collaborative approach between client and mentor. In the mentoring relationship, the mentor role helps facilitate change; The client agrees to honest, direct communication about what is working and what changes need to occur. If the client believes the mentoring is not working as desired, the client will communicate this with the mentor as soon as possible and the mentoring strategy will be restructured to address the client's desired outcome of mentoring.

MENTAL HEALTH/MEDICAL HISTORY

The client also agrees to disclose details of the past or present psychological, psychiatric treatment &/or significant medical treatment. Mentoring and counseling are not the same. Likewise, therapy and other modes of professional or medical psychological examination shall not be considered equivalent to mentoring. I am not a registered psychologist or psychiatrist, nor a licensed therapist. I do not engage in therapy with my mentoring clients.

CONFIDENTIALITY

All information about the mentor/client relationship will remain strictly confidential except in very rare circumstances where decreed by law; i.e. where the court might issue a subpoena for the file or information. In order to ensure the most effective support for the client, Sharing is Healing requires the following consents to release confidential information be signed: 1) Primary Care Physician 2) All past/current mental health counselors/psychologists 3) Psychiatrist 4) Payee if other than the client 5) Additional consents which may be needed include: family member/partner. It is also important to note that in some situations, it is important to be aware of the use of technology in that for some clients, there is a risk in using certain media such as the internet, mobile phones and cordless phones. If you use these to communicate with me, then I will assume that it is appropriate to continue to do so in my interactions with you.

TERMINATION
